**Re-Invitation for Bids for the Construction of Office Building**

1. The Government of Nepal [GoN] *has allocated funds* towards the cost for Construction of Office Building and intends to apply part of the funds to cover eligible payments under the Contract *for Construction of Office Building*, Bheerkot Building/NCB/02/074/75. Bidding is open to all eligible as per Section V of bidding document.
2. **Office of Bheerkot Municipality** invites electronic bids from eligible bidders for the construction of **Office Building** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.


Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: is NRS 6,50,00,000/-
  - Minimum work experience of similar nature in the last 10 years is 1 number of R.C.C frame structure building having value of not less than 6,80,00,000/-
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
  4. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

6. Pre-bid meeting shall be held at Office of Bheerkot Municipality, Bayarghari, Syangja at 2:00 pm on 15<sup>th</sup> June, 2018.
7. Electronic bids must be submitted to the office of **Bheerkot Municipality** through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 12: 00 pm on **26th June, 2018**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on **26<sup>th</sup> June, 2018** at the office of **Bheerkot Municipality, Bayarghari, Syangja**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRS 24,00,000 /- (Twenty four Lakh only) , which shall be valid for 30 days beyond the validity period of the bid. The eligible bidder should deposit bid security in account as specified below:
