4. Pre-bid meeting shall be held at Bheerkot Municipality Office, Bayarghari, Syangja at 2079/6/27.
5. Electronic bids must be submitted to Bheerkot Municipality office through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) or before 2079/7/06 at 12:00. Bids received after this deadline will be rejected.
6. The bid will be opened in the presence of Bidders' representatives who choose to attend at 2079/7/06 at 13:00 at the office of Bheerkot Municipality, Bayarghari, Syangja. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
